INSTRUCTIONS FOR USE AND DOSAGE:

Place one SANIVEX MULTI KLEEN TAB PRO into a KLEEN PURGATIS foam spray bottle filled with 500 ml water and close it thoroughly. Let the tab dissolve completely. Spray the ready-to-use cleaning solution onto a cloth and wipe the surface evenly and overlapping. Before use, check material compatibility in an inconspicuous place. If used or applied incorrectly there will be no claims accepted. Ready-to-use solution must be used within 4 weeks. Seal the pouch after removing a tab and store in a dry place. Bottle is reusable. Rinse carefully before refilling.
