- **not** applicable on marble, artificial stone and acid proof surfaces

APPLICATION RANGE:

Cleans and descales below the water line (discharge pipes) and sanitary installations containing water. **Not** applicable on marble, artificial stone and none-acid-proof surfaces.

INSTRUCTIONS FOR USE AND DOSAGE:

Open foil - add tab to water section of sanitary installations. The dissolving process adds active agents to the water - producing an active foam. Let the resulting cleaning solution take effect (maintenance cleaning approx. 5 minutes, Basic cleaning between 10-15 minutes), followed by thoroughly flushing. Strongly contaminated installations should be cleaned by using the brush. For hygienic cleaning it is recommended to place the brush into the bowls during the self-activation-dissolving process of the tabs. **If improperly applied - and for claims resulting from such improper handling - there will be no legal claims accepted.**
